TO: ALL PFSC Counties/Clubs
RE: PFSC CLUB CREDENTIAL SHEETS & INSTRUCTIONS

Attached are the new PFSC club credential sheets to be used by all PFSC affiliated clubs and counties. Please make your own copies as needed. (Forms may be downloaded from website.) **The county delegate is responsible for following up with each of the clubs in their county.**

GENERAL INSTRUCTIONS:

- **CLUBS** pay state, county, and division dues and submit completed CLUB information, to include 10 members and their contact information, to the county by February 1st. (Every club that paid in current year will receive a club credential sheet directly from the state office by early Nov.)
- **COUNTY Secretary or Treasurer** verifies members and dues for each club. Forwards division dues and copy of credential sheet to Division Treasurer **by February 15th**.
- **COUNTY Secretary or Treasurer** updates records and forwards **STATE DUES** and all club credential sheets to PFSC **before February 15th**. **Note:** Some Divisions require credentials & payment to be sent to them, then they will forward to the state office. Please, contact your Division for more info.

IN ADDITION, the PFSC State office now requires all CLUBS to provide the following information:

- Names and addresses of at least 10 members of the club. (Names will not be sold or distributed.)
- At least one e-mail contact for each county and club, as this is the most timely and effective way to communicate, who will relay the info to their club/county members. You don't want to miss out on any important information.

<u>Number of Members</u>	<u>Rate</u>
10-19	\$50
20-29	\$80
30-39	\$110
40-49	\$140
50-59	\$170
60-69	\$200
70-79	\$230
80-89	\$260
90-149	\$290
150+	\$290 + \$1 for each member over 149
984+	\$1125 cap!

Examples:

- If your club has 200 members, you pay \$341
 - $200-149=51$
 - $51 \times \$1 = \51
 - $\$290 + \$51 = \$341$
- If your club has 500 members, you pay \$641
- If your club has 950 members, you pay \$1091
- If your club has 984+ members, you pay \$1125

Individual Membership Rebate Program for Clubs, Counties, Divisions & Statewide Orgs:

For each \$25 Individual membership your group collects for PFSC, you may keep \$5 and forward \$20 to the state. (\$10 from \$50 memberships & Life memberships) Note: Any payments made directly to PFSC will not result in a payment back to a club or group, so you must physically collect the payment and take the instant rebate out before submitting the balance to the state.

Statewide Organizations

Statewide organizations shall be any bona fide statewide conservation organization with a membership of 500 or more, and whose mission is consistent with that of the Federation. Acceptance as a member will be contingent upon a majority vote of the Delegates. Statewide organizations in good standing shall elect a Delegate and Alternate Delegate to represent them to the Federation.
